SUMMARY OF QUALIFICATIONS

In June 2006 I transferred to the Department of Leadership, Command and Professional Development as a resident program faculty. In this capacity I assist in the design, development, and implementation of resident program curriculum. In addition, I teach all three Leadership, Command and Professional Development courses. Further, I facilitate a research seminar focusing on leadership in an asymmetric environment.

Previously I served as the Deputy Chairman of Curriculum Development for Distance Learning at the Air Command and Staff College. I have an extensive background in education and training, military affairs, and international business that adequately qualifies me to teach the entire ACSC Curriculum. I have taught a variety of courses at the secondary, undergraduate, and graduate levels. With over twenty-five years experience in the design, development, implementation, and evaluation of education and training programs across many cultures I have provided visionary leadership to the ACSC Distance Learning Program.

In addition, I have over ten years of international business experience. This has given me an appreciation of and for cultures around the world. At Harcourt Brace, I developed an international sales force with agent offices in the Israel, Jordan, the UAE, India, Thailand, Singapore, Taiwan, the Philippines, Mexico, Central and South America, the Pacific Islands and throughout the Caribbean. My client base was worldwide. In addition, I have practical international relations expertise that was gained by my work with business people, educators, and the ordinary person on the street. My interest in other peoples their culture, history, and perception of Americans enabled me to gain knowledge far beyond that which can be learned in the classroom or from books. The knowledge and understanding thus acquired enabled me to not only increase sales revenues but also develop local infrastructure under the leadership of local people. Militarily, I spent six years on active duty. I am credited with over fifty combat aerial assaults and extractions while the Platoon Leader of an elite airborne unit in Vietnam. My follow-on assignment was with the DCSI, USAREUR & 7th Army, and later with the DCSI, US Commander, Berlin. In these three assignments, I developed cross-cultural communications skills while working with Vietnamese, UK, and French forces. I also garnered experience working with numerous US and foreign intelligence organizations. Research focus: Assessment of Airborne Operations in WWII, Coastal Defense of the US in WWII, Development of an integrated air defense system after WWII, development of Just War Theory.

Deputy Chairman, Curriculum Development and Professor of Distance Learning, Air Command and Staff College, Maxwell AFB, AL (Jan 1999-Jun 2006). As the Deputy Chairman of Curriculum Development I provide expert guidance on curriculum development, instructional methodologies, program evaluation, and institutional research in the ACSC Distance Learning Program. Currently, I am an active member of the Air Education and Training Command (AETC) Focus Group for Advanced Distributed Learning (ADL). In addition, I am presently advising DL Course Directors on the integration of cross-cultural competencies through each course in the DL Program. I was the Associate Dean of Distance Learning for four years. On two occasions – June to August 2004 and again in 2002 I was the Acting Dean of Distance Learning pending the appointment of a new AF officer as Dean. I was the DL point man for the Southern Association of Colleges and Schools (SACS) accreditation effort. I assisted the Air Force Institute for Advanced Distributed Learning (AFIADL) in its reaccreditation effort by the Distance Education and Training Council (DETC). Arriving at ACSC in 1999, I took charge and transformed the ACSC DL program from a bland paperless CD-ROM based program to a well-balanced graduate level multi-media educational program. This program received outstanding and excellent ratings from Air Force inspectors and its accreditation was affirmed on two occasions by the J-7 Office of the Chairman, Joint Chiefs of Staff. This program has also received rave reviews from several other organizations. I spearhead an aggressive applied research effort having acquired four grants valued in excess of \$150,000. The focus of these projects was on existing and emerging educational technologies for possible incorporation into our program, specifically the use of electronic essay grading and eBook technology. I developed affiliation agreements with five graduate schools to grant transfer credit for those completing our DL program. I conduct academic research in the areas of distance education, adult learning theory, performance improvement, and program evaluation. My military related research efforts are on 4th Generation (Asymmetric) Warfare, use of Chemical, Biological, Radiological, Nuclear, and High-yield Explosive (CBRNE) weapons of mass destruction (WMD) by non-state actors, National Strategy, ethics, and treaties. I am a contributing member of three academic committees at ACSC and Air University. As a member of the ACSC Strategic Planning Committee, I helped develop the ACSC 5-year plan and recently revised the DL portions of it. In seven years, I have authored and published over nineteen articles in professional journals. As a faculty research advisor, I guided the research efforts of seven students who have had their papers published in referred professional journals. I am an excellent team/consensus builder. Outside of ACSC, I review articles for *Contemporary Security Policy* (2005-Present), and served as a reviewer for *Academic Exchange Quarterly*, *TCRecord*, and *The Internet and Higher Education* (2000-2005). I was also a book reviewer for *Air Power History* and *TCRecord* (2000-2005). In January 2002, I was appointed to a second 3-year contract and in September 2004, I was appointed to a 5-year contract. In summary, for over seven years I have provided visionary leadership to the ACSC DL Program.

President, Educational and Psychological Services International, Oviedo, FL (Dec 1995-2003). EPSI is a subchapter 'S' corporation offering educational and training consulting services to domestic and international clients. As a consultant to Ontar Corporation, I was a key contributor to the development of the Training and Education Network On Request (TENOR) training system. In addition, I worked as a research scientist on several Small Business Innovative Research (SBIRs) projects. I built collaborative partnerships among Ministries of Education throughout the Caribbean. EPSI provided professional development workshops to the Ministry of Education, Trinidad and Tobago that resulted in the revamping of the reading and language arts curricula. While representing Rigby Publishers I tripled revenues in the international territory assigned honing his strategic business plan development skills. While serving as the international representative for Riverside Publishing I doubled sales revenues. As President of EPSI I attended, numerous Professional International Conferences where I made numerous presentations. Also, I participated in standardizing tests and conducted other types of research.

I co-authored several technical research reports, published by the Human Factors Division of the Naval Training Systems Center. These reports described our findings on the enhancement of aircrew development and performance. I designed and developed an aircrew observer-training (ACOT) course for the US Marine Corps. This training improved the team coordination skills of helicopter crewmembers. As an assistant research scientist I assisted in the supervision of doctoral students in their applied human factors research. Their research was concerned with team development and coordination as it pertained to aviation. Many of these students published their research results and presented their findings at annual meetings of the American Psychological Association. During this period, I was also an adjunct instructor in the College of Education teaching educational measurement and applied research. I was inducted into Psi Chi, the National Honor Society in Psychology as a result of my human factors work at the Team Performance Laboratory.

Adjunct Instructor, University of Central Florida, Department of Educational Foundations, College of

Education, Orlando, FL (Sep 1991- Dec 1999). I taught two graduate level courses for the Department of Educational Foundations as an adjunct instructor: Measurement and Evaluation, and Fundamentals of Graduate Research in Education.

I developed the conceptual design for an interactive videodisk logistics support system and discussed this system in an article published in *Spectrum*, the official publication of the Society of Logistics Engineers. This system was designed so sailors could electronically access technical manuals and, when necessary, receive 'on-demand' refresher training at critical locations while on-board the ship. I won a contract with Canada Post that was especially challenging. One part of the effort required that I work with engineers to design a part-task trainer that emulated the functions of the actual keypad of the mail-sorting device used by Canada Post. The other part required I design an 'on-demand' system so that all the training materials were located on a mainframe computer in Toronto so lessons could be downloaded by training managers to the trainee's work location. After the learner had completed the training module, results were then electronically sent back to the mainframe and the trainees' personnel records updated accordingly. In addition to marketing interactive training services and systems I also marketed optical information storage and retrieval systems domestically. Further, I directed the writing of business proposals, joint venture agreements, and negotiated contracts. I published over twelve articles and made eighteen presentations on training and training systems at professional conferences sponsored by the US Air Force as well as the Ministry of Defence, Canada. Finally, I completed my doctoral studies and was inducted into Kappa Delta Phi, the International Honor Society in Education and I was the President of the Parents Advisory Council and Board of Trustees at the University of Tampa.

Director, Instructional Systems Development, Deterline Corporation, Kissimmee, FL (Oct 1985- Jun 1986). I left Martin Marietta to work for Deterline. I supervised two departments that designed and developed five corporate and military training programs. In addition, I managed the writing of two business proposals, and formulated and negotiated three joint venture agreements.

Later I designed three training systems and coordinated the approval process with the US Army Missile Command at Redstone Arsenal. I also conducted research and developed an interactive videodisc logistics support system a description of which was published by the Society of Logistics Engineers. I conducted feasibility studies for the US Army Missile Command and wrote two technical reports focusing on the use of interactive videodisc systems for depot level training. While at Martin Marietta, I earned four publication awards for my work in training research. I was a frequent presenter at professional conferences. In addition to my duties at Martin Marietta, I worked on my doctoral degree in Curriculum and Instruction.

Instructional Designer, Educational Services, Analytic Systems Engineering Corp., Burlington, MA (Jan 1981-Sep 1983). At ASEC, I was responsible for analyzing the educational needs of selected US Army Officers. I directed and managed the design and development of Signals Intelligence (SIGINT) and Electronic Warfare (EW) officer programs and supervised the development of criterion-referenced tests for enlisted SIGINT/EW occupation specialties. Also, I published an article in *Military Intelligence*

magazine on implementing the CEWI concept in the army reserves.

I wrote marketing and new business development plans for New England, and coordinated the writing of six business proposals. I prepared and maintained capital and operating budgets.
